Nominees are required to submit their profile, bio-data and comprehensive manifestos drawn up in accordance with Article 2.0 (Fundamental Objectives) of the NIQS Constitution.

Nomination forms shall be personally delivered in a sealed envelop and deposited into a Three (3) point sealed box conspicuously positioned at the National Secretariat, in Abuja, **not later than 12.00 noon, on 19<sup>th</sup> September 2017**. Opening of the submissions, by members of the Biennial Election Panel (BEP), shall be on the same day at 2.00pm. All nominees are expected to be present at the Secretariat, by 9.00am on the 20<sup>th</sup> day of September, 2017 for screening by the BEP.

Candidates eligible for nomination, shall be as provided by Article 6.2.5 of the NIQS Constitution 2015 (as amended). Members are advised to go through these provisions before completing their nomination forms. However, due consideration will be given by the BEP to Article 2.0 (viii) of the Constitution, during screening.
