- i) Nominee's current Profile including duly endorsed photocopy of relevant Certificates by the Nominator;
- ii) A comprehensive Manifesto as per Article 1.4 (i) and 1.6(1) of the First Schedule of the NIQS 2004 Constitution (2nd Amendment 2015);
- iii) Nominee's current Passport photograph with name and signature at the back and attached to the Nomination Form; and
- iv) Electronic (scanned PDF) copy in a flash drive and the hard copy nomination documents appropriately submitted by the nominee to NIQS, head office complex Abuja in a sealed brown envelope addressed to: **THE CHAIRMAN, 2023 BEGM ELECTION PANEL.**

E. SCREENING OF NOMINEES: Nominees would be screened virtually on 26th September, 2023. (More details about the screening will be made available in due course).

G. MEANS OF IDENTIFICATION OF VOTERS: the means of identification shall be the **NIQS Identity Card** as provided on the Institute's Mobile App and/or any other nationally recognized means of Identification **i.e. Permanent Voters Card, Driver's license, National Identity Card or International Passport.**

H. To ensure that the Biennial Election process focus on professionalism and positive addition to Quantity Surveying Profession and the Institute as a whole, the campaigns shall be guided by the following Rules:

1. Candidates are expected to conduct themselves in the most civilized manner and the campaigns must be done without any form of acrimony;
